- The Executive Engineer PWD Building Division Bhimber on behalf of the employer invites sealed bids, under Single Stage Single Envelope Bidding procedure, from eligible firms or constructors licensed by the Pakistan Engineering Council (PEC) for the year 2023-24 and duly endorsed by the office of the Chief Engineer Buildings/PHE South Muzaffarabad in the appropriate category with field of specialization as mentioned in column No.4 for the above mentioned work. Any information/further detail can be obtained from office of the undersigned.
- A complete set of Bidding Documents may be purchased by an eligible bidder on submission of a written application to the Executive Engineer PWD Building Division Bhimber upon payment of non-refundable fee, as mentioned in column No. 5 on or before 19 September, 2024 during the office hours.
- The application must be accompanied by a declaration/Affidavit that he or his firm is not blacklisted by any department of AJK /Pakistan.
- Bidding documents will be issued only to the constructor/Firm or their authorized representatives who will show the original power of attorney along with original authority letter.
- The bidders are required to submit their bids at 11:30 AM on 19 September, 2024 in the office of undersigned. Bids will be opened by the bid opening committee at 12:00 Hrs on the same day in the presence of bidders or their representatives who choose to attend.
- The bidder should quote his rate in percentage above /below or at par of MRS 2nd Bi Annual District Gujrat 2024 for District Bhimber for schedule items. The bidder has to quote his rate in figures limiting up to two decimal places.
- The call on Deposit (CDR) must be issued by a schedule Bank of Pakistan, having its branches in Azad Jammu & Kashmir and the Bank of Azad Jammu & Kashmir.
- All CDRs except of successful bidder shall be released after due verification. No CDR will be released on the bidding day.
- Conditional, incomplete and bid filled with led pencil will not be acceptable.
- The Competent authority in accordance with PPRA Rule -33 reserves the right to reject any bid or all Bids at any time prior to the acceptance of bid.
