
## TENDER NOTICE:-

AJK Electricity Department Muzaffarabad invites sealed bids (on open competitive bidding basis single stage one envelop) from WAPDA/DISCOS/NTDC pre-qualified manufacturers, registered with WAPDA/DISCOS/NTDC and AJKED for below mentioned stores according to relevant WAPDA/IEC/BS specifications (amended to date) as mentioned in the bidding documents. Tenders should reach in this office on or before **15-01-2025** at 11:00 (a.m) which shall be opened on the same day at 11:30 (a.m) in the office of the Chief Engineer Electricity Muzaffarabad (Chairman Departmental Purchase Committee) in the presence of bidders or their authorized representatives who choose to attend the meeting:-

### IMPORTANT CONDITIONS :-

1. All store items (material) be supplied strictly according to relevant WAPDA/IEC/BS specifications (amended to date).
2. Each bid/tender should be supported with a Bid security (in the form of Call Deposit receipt, Demand Draft, Pay Order, valid Bank Guarantee issued from any scheduled bank to be verified) for the amount mentioned in Bidding Document, in favour of the Chief Engineer Electricity Muzaffarabad. Validity of Bank guarantee should not be less than 90 days from the date of bid/tender opening.
3. All terms and conditions governing this tender are mentioned in the bidding document (ready for obtaining) which can be obtained on payment of Rs.700/- each (cost of printing and providing the document) up to **14-01-2025** during office hours from this office.
4. Bid documents will be issued to the representative of the manufacturers holding authority from their Principal for obtaining the document and participating in bids.
5. WAPDA/DISCOS/NTDC pre-qualified manufacturers who are registered with FBR Sales tax and Income Tax department are eligible to quote their rates.
6. Rates should be quoted exclusive of General Sales Tax on Free Consignee Store (FCS) Muzaffarabad A.K basis.
7. All the prevailing taxes/duties levied in A.J.K will be deducted from the successful bidder's bills.
8. Conditional bids/tenders will not be entertained.
9. Validity of rates should not be less than 60 days from the date of bid/tender opening.
10. Bidders can quote Item wise rates, however rate offered for partial quantity will not be entertained.
11. Black listed firms/ companies/ suppliers/ distributors/ contractors/ bidders are prohibited for participation. All bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with government anywhere in territory of the state of the AJK, federally administrated areas of Islamic Republic of Pakistan.
12. The Competent Authority (DPC) shall reserve the right to accept or reject all or any bid as per AJK PPRA rules.
