



The Bank of Azad Jammu Kashmir (The "Procuring Entity") invites the Technical and Financial bids as per AJKPPRA Rule 36 (b) Single Stage Two Envelop from reputed Firms/Contractor for the Project titled **RENOVATION OF KHURSHEEDABAD, MUMTAZABAD, JABI & GULPUR BRANCHES IN RAWALAKOT, MIRPUR & KOTLI REGIONS AJ&K**, having adequate experience in carrying out the projects of similar Nature.

1. The Procuring Entity invites sealed bids from eligible Firms/Company having Valid and Active licensed by the Pakistan Engineering Council. Bidders may obtain further information from, inspect at and acquire the bidding documents from the office of the **Divisional Head Operations, Head Office Sardar Nazir Plaza Gojra Bypass Muzaffarabad AJ&K** up to January 13, 2025 during office working hours.

A complete set of Bidding Documents may be obtained by an interested bidder's on submission of a written application to the above office and upon payment of a non-refundable fee Rs. **4,000/-** in the form of CDR/Banker cheque on the name of Bank of AJ&K for project "**RENOVATION OF KHURSHEEDABAD, MUMTAZABAD, JABI & GULPUR BRANCHES IN RAWALAKOT, MIRPUR & KOTLI REGIONS AJ&K**" up to January 13, 2025 during office working hours from the office of Divisional Head Operations Establishment Section, Head Office Sardar Nazir Plaza Gojra Bypass Muzaffarabad AJ&K.

Under Single stage Two envelop procedure the sealed envelope containing Technical & Financial bids (Should be clearly marked as Technical & Financial Bids) as per the requirement given in the bidding document and Technical & financial Bid must be submitted to the office of the Divisional Head Operations Establishment Section on or before January 14, 2025 up to **11:30 AM** through courier or registered mail (**No bid will be received by hand**) the same will be opened at **12:00 PM** on the same day in the presence of bidder's/ Authorized representatives who desire to attend, in the Committee room of BAJK.
4. All bids must be accompanied by a Bid Security in the shape of Call Deposit from Bank of Azad Jammu & Kashmir or any schedule Bank (Not pay order), amounting **Rs. 840,000/-** on the name of Bank of Azad Jammu & Kashmir.
5. Pre bid meeting will be held on January 03, 2025, at **11:30 AM** at the Committee room of BAJK Head Office located at Sardar Nazir Plaza Gojra Bypass Muzaffarabad AJ&K.
6. Application received after the closing date shall not be entertained.
7. Financial Bid must be quote inclusive of all Taxes.
8. Valid NTN/GST registration certificate must be provided with the Technical Bid.
9. The firm must apply on its own independent profile not a JV arrangement, Application proposing JV will not be accepted.
10. The competent Authority reserves the right to reject any or all tenders in accordance with AJK PPRA rules.
