NOTICE INVITING E-BIDING

(Under Single Stage-Two Envelope E-Bidding System)

Communication & Works, "Highways Division Jehlum Valley" Govt. of Azad Jammu & Kashmir invites Tender via Electronic Bidding Procedure in accordance with AJK PPRA Rules 36(b) as per Single Stage-Two Envelope Bidding Procedure from the eligible Firms/Contractors licensed by the Pakistan Engineering Council and having endorsement in C&W Govt AJ&K for FY 2024-25 in appropriate category as mentioned against work in column 5 below with **Specialization Code CE-01 for Roads & Code CE-02 for Bridges** for the following work. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provisions of PEC by-laws. Bidders desirous to bid as Joint Venture must get prior approval from the Employer for bidding as joint venture.

Bidding is open to all eligible Bidders

- i. The newly registered bidders are directed to get username and login details from IT Section, Office of The Chief Engineer Highway Muzaffarabad Block H, DHQ Muzaffarabad. Bidders/Firms which are already electronically registered with the Department can use already provided username & password
- ii. Bidding Documents and instructions to Bidders can be downloaded from bidder's dashboard.
- iii. Interested bidders are required to submit their Electronic Bid (Technical & Financial) upto due date & time mentioned in column 7 above. Technical Bids will be opened by E-Tendering System as per schedule i.e **11:30 am on 19 April 2025** as mentioned in column 7 above.
- iv. The interested bidders shall upload scanned copy of Bank Receipt showing proof of deposit of Bid Security in anyone of the following Divisional Joint Account,
 - a) N.B.P Hattian Bala PK41NBPA0673003070268080
 - b) M.C.B Hattian Bala 0999-1329 81002416
 - c) Bank of AJK Hattian Bala 034-11265001along with their relevant documents on its Dashboard.
- v. The interested bidders shall upload their Technical Bid complete in all respects on E-Bidding Dashboard. Hard copy of Original Bank Receipts of Bid Security along with Technical Bid & Bidding Documents (uploaded by Highways Division Jehlum Valley) duly signed & stamped by the Contractor/Firm must be submitted in the office of the Executive Engineer Highways Division Jehlum Valley Hattian Bala AJK within 48 hours after opening of Technical Bid through E-Bidding system.
- vi. As E-Bidding software supports only PDF file Format for Technical Profile uploading option, therefore interested bidders shall upload their Technical Bid in PDF file format only.
- vii. The Contractors/Firms quoting their rates below 10% of Engineering Estimates shall submit additional bid security in shape of CDR in sealed envelope with Financial Bid, equal to the difference between Engineering Estimate and Bid price.

- viii. The bid securities of unsuccessful bidders will be returned through Divisional Cheque upon award of the contract to the successful bidder(s) or on the expiry of validity of bid, whichever is earlier.
- ix. Electronic Bidding shall be done on **percentage (Above/Below/At par) Basis**. Only Two digits after the decimal point shall be considered for evaluation purposes.
- x. Blacklisted Firms/Contractors/Companies/Suppliers/Distributors are not allowed to participate in the bidding process. The interested bidders shall furnish an affidavit/certificate that they are neither blacklisted nor involved in conflict with Govt. anywhere in territory of the state of AJK or in all provinces of Islamic Republic of Pakistan.
- xi. Any Bidder(s) who provides incorrect information or does not submit hard copies of Technical Bid & Bid Security uploaded on its dashboard along with complete bidding documents shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
- xii. Pre Bid meeting will be held on **April 15, 2025** at 11:30 A.M in the Office of Superintending Engineer PWD Highways Circle, 1st Floor, Block -H District Complex Muzaffarabad.
- xiii. Other terms & conditions are available in the bidding documents.
- xiv. The competent authority reserves the rights to reject all or any bid under the Clause 33 of AJK PPRA Rules.
