NOTICE FOR INVITING E-BIDDING

(Under Single Stage-Two Envelope E-Bidding System)

Highways Division Kotli Azad Kashmir Communication & Works Department, Govt. of Azad Jammu & Kashmir invites Electronic Bid in accordance with AJK PPRA Rules 36(b) as per Single Stage-Two Envelope Bidding Procedure from the eligible Firms/Contractors licensed by the Pakistan Engineering Council and having endorsement in C&W Govt AJ&K for FY 2024-25 in appropriate category as mentioned against each work in column 5 below with Specialization Code CE-01 for Roads. Bidders desirous to bid as Joint Venture must get prior approval from the Employer for bidding as Joint Venture.

- The newly registered bidders are directed to get username and login details from IT Section, Office of The Chief Engineer Highway (North) Block H, DHQ Muzaffarabad. Bidders/Firms which are registered with E-Bidding in the Department can use already provided username & password.
- Bidding Documents and instructions to Bidders can be downloaded from contractor's dashboard. Moreover, detail of road and drawings can be obtained from office of Executive Engineer PWD Highways Division, Kotli during office hours.

- 3 The interested bidders shall upload scanned copy of Bank Receipt showing proof of deposit of Bid Security as mentioned in column 6 above, in the Divisional Joint Account:

- along with their relevant documents on its Dashboard.
- 4 Performance security is fixed as 5% of bid price. However Any Contractor/ Firm, who quotes its rates below than 10% of Engineering Estimates, shall submit additional Performance security equal to 5% of its bid price in the light of clause#39 of AJK-PPRA Rules. The Contractor/Firm shall submit this performance security in form of CDR or unconditional on demand bank guarantee from scheduled bank of Pakistan having its branches in AJK or Bank of AJK as amount mentioned in Letter of Acceptance.
- 5 The bid securities of unsuccessful bidders will be returned through Divisional Cheque upon award of the contract to the successful bidder(s) or on the expiry of validity of bid, whichever is earlier.
- 6 Electronic Bidding shall be done on percentage (Above/Below/At par) Basis. Only Two digits after the decimal point shall be considered for evaluation purposes.
- 7 Blacklisted Firms/Contractors/Companies/Suppliers/Distributors are not allowed to participate in the bidding process. The interested bidders shall furnish an affidavit/certificate that they are neither blacklisted nor involved in conflict with Govt. anywhere in territory of the state of AJK or federally administered areas/all provinces of Islamic Republic of Pakistan.
- 8 The interested bidders shall upload Letter of Bid of the Firm/Contractor, other documents required for qualification/responsiveness as per Bid Data Sheet on E-Bidding Dashboard.
- 9 Hard copy of Original Bank Receipts along with Bidding Documents (Technical / Financial) duly signed & stamped by the Contractor/Firm must be submitted in the relevant office of the Executive Engineer Highways Division Kotli within 48 hours after opening of bid through E-Bidding system, otherwise such bidder/bidders will be declared as disqualified.
- 10 In E-Bidding System, the software supports only PDF file Format for Technical Profile uploading option, therefore interested bidders shall upload their Technical Profile in PDF file format only.
- 11 Any Bidder(s) who provides incorrect information or does not submit hard copies of complete bidding documents including those documents uploaded on its dashboard, shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
- 12 The competent authority reserves the rights to reject all or any bid under the Clause 33 of AJK PPRA Rules.
