Tender/Bids complete in all respects should reach on or before 06th April, 2026 till 11:00 am in the office of the Director General, State Disaster Management Authority Block No. 10 New Secretariat, Chatter Muzaffarabad Azad Kashmir, which shall be opened on the same day at 11:30 am by Committee in the presence of Bidders or their authorized representatives who opt to attend the meeting.

TERMS & CONDITIONS: -

1. The bidding document contains detailed specifications instructions and conditions for those who intend to participate in the bidding process and all interested manufacturers / firms / importers / bidders / suppliers/ authorized dealers are earnestly advised to read the bidding document before submission of their proposals / Bids which can be obtained against the bidding documents for a non-refundable cash payment of Rs. 2500/- (non-refundable) from the office of Director State Disaster Management Authority, Block No. 10 New Secretariat, Chatter Muzaffarabad Azad Kashmir, on or before 03rd April, 2026 during the office hours by submitting a written request on the firm/company letter head.
2. Black listed Firms/Companies/Suppliers/Distributors/Contractors/Bidders are prohibited for participation and all bidders shall furnish an affidavit/certificate that they are neither black listed nor in conflict with Government anywhere in territory of the State of the AJK, federally administrated Areas or Islamic Republic of Pakistan.
3. Financial guarantee from insurance companies shall not be accepted.
4. Call deposit/Pay order receipt of Rs. 500000/- for Package I and Rs. 70000 for Package II and Rs. 1200000/- for Package III should be submitted in favor of Deputy Director Operations SDMA Muzaffarabad Azad Kashmir, rates offered without CDR, pay order will not be entertained.
5. Bid prices must be quoted on the relevant page of bidding document i.e. price schedule for the items to be offered, duly filled, signed and stamped by authorized representative of bidder, supported by the bid security.
6. Pre delivery inspection will be carried out before taking over the ordered items.
7. Quoted price of the offered items should include all enforced applicable taxes vogue in AJ&K.
8. The successful bidders shall be bound to supply the ordered items/works within 30 days (Package I and II) and 60 days (Package III) from the date of issuance of work order.
9. Incomplete and conditional offers shall not be entertained.
10. Brochures of Fabrication (Package III) with detailed specifications must be provided at the time of submission of bids.
11. Samples of the quoted items (Package I and II) must be submitted at the time of bidding, otherwise the bidder without sample will be disqualified.
12. Package No. for which the bid is being submitted should must be clearly mentioned/marked at the sealed envelope.
13. The competent authority reserves the right to accept or reject any quotation in part or full assigning any reason therefore.
